- 2. The October minutes were approved.
- 3. Public comment (from Josh Folb, representing the AEA)
 - Josh presented his annual salary comparison (Teachers with master's scale)
 - o http://www.tinyurl.com/compaps2018
 - Arlington lagging across the region for starting salaries and ending salaries
 - AEA continues to stress a multi-pronged approach for compensation: observe the market, stay current with COLA (recommending 5.9%), keep the STEP
 - Supports \$1,000 bonus to staff (for full time staff; prorated for part-time and \$500 for hourly) from close out funds
- 4. School Board Update Monique O'Grady
 - Dr Duran's proposal to honor staff with bonuses
 - Closing for winter/spring break to help staff with more down time
 - School Board priorities to look at compensation and be better leaders in that area
 - Bond passed in recent election primarily to fund upgrades to kitchens, security, attention to The Heights building
 - CIP direction approved by School Board
 – continued work on security, Career Center, and renovations to existing buildings
 - Amazon partnership
 - More information to come on close-out details
- 5. BAC Liaison Comments
 - ACTC: County working with ART to provide free bussing; starting with a pilot program
 - Goal for APS to flatline bus expenditures going forward
- 6. IT Efficiencies Raj Adusumilli (APS Information Services)
 - Rad reviewed the main takeaways from the recent presentation to the Board on efficiencies
 - Been a challenging time for IT over the past 2 years
 - Instruction:
 - Standardized the model to replace Smartboards through a rotation program

Infrastructure:

- Wireless access points replaces one-fifth each year; plus added outdoor wireless access at 35 school sites
- o Backbone uses ConnectArlington
- Network architecture/internet access
- Any family needing connectivity is supported via Comcast and mifis this was a partnership with the County
- o Switches still need to be addressed with a sustainable replacement plan

Business Systems:

- ERP upgrade Oracle Financials since 2005 (for HR and Finance); version being discontinued so being forced to upgrade/reevaluate
- 3-year timeline to move everything to the Cloud
 - If this is delayed there will be other costs incurred to keep the current systems running
- There has not been a comprehensive comparison of IT spending against other jurisdictions – Raj assumes APS is at a lower cost level due to the strong support we have from the county via ConnectArlington

7. Evaluating Efficiencies Discussion

- Is there a framework to use to evaluate options?
- Benchmarking helpful could it be feasible to bring in an outside expert to help with this?
- Can efficiencies drive more equitable outcomes?
 - Need to ensure standards of quality
- Historically most successful efficiency implementations have been ones with a process
- Level of flexibility each school has and how that creates complexities in running a school system (versus a system of schools) and being able to evaluate efficiencies

- Will review BAC specific part of advisory committee policy in the spring
- Still waiting on dates for some policy reviews

9. Way Ahead – Chuck Rush

- Dec meeting: Choice schools cost and benefit, and new equity officer
